# FOOTBALL CAMP TERMS & CONDITIONS

PAGE 1 OF 3

In these terms and conditions a reference to 'you' or 'your' means a reference to the person applying to book a course and a reference to 'participant' means the person for whom a place on a course is booked. A reference to 'we', 'us' or 'our' is a reference to RB Football Development, courses, camps and academy always means RBFD Football Camps/Academy.

This page tells you the terms and conditions on which we provide courses. Please read these terms and conditions carefully and make sure you understand them, as by booking and attending a place on a course, you agree to these terms and conditions.

#### **Your Booking**

- 1. After you have purchased a place on a camp, you are booked on and will begin to receive correspondence from RBFD and/or the partner site shortly thereafter. A contract between us is formed as soon as payment is made.
- 2. By applying to book a place on a course you confirm that: (a) you are legally capable of entering binding contracts; (b) you are at least 18 years old; (c) your application is in a private capacity for an individual/or sibling participant/s with whom you have a personal relationship and you are not applying for places on courses which you intend to resell in the course of a trade or business.
- 3. The price of courses are those stated at booking. You are responsible for arranging and paying for the participant's return travel to the course venue.
- 4. All registrations must be with a view to providing full payment of the appropriate course fee.
- 5. Any cancellation must be requested in writing, to hello@rbfootballdevelopment.co.uk in the first instance, and no refund can be awarded after 14 days prior to the commencement of camp.
- 6. Where a participant is unable to attend, a booking may be transferred to another suitable child, at your request.
- 7. All courses are subject to change according to weather, venue availability, a satisfactory number of participants, and other factors beyond our control. As such, we may cancel or change any courses, should this be necessary for these reasons. If we do have to cancel a course, we will offer an alternative course (if available and suitable), or a full refund.
- 8. Where sessions take place on all-weather pitches, courses will not be cancelled due to rain and wet conditions, where it is safe for play to go ahead.
- 9. You are responsible for arranging and paying for suitable insurance to cover any injury or illness that may prevent the participant from attending, as unfortunately, we cannot provide a refund without NHS verified certification, with a 7 day-notice minimum.
- 10. For the avoidance of doubt, no refund is permitted for participant's failure to attend the course, or partial refund where there is a failure to attend on-time.

#### **Health and Wellbeing**

- 11. You must ensure that the participant is physically fit and able to participate in the sporting activities. If you need any further information on the physical fitness required of participants or have any doubt that a participant is sufficiently physically fit to attend a course please contact us before applying for a place on a course. We will not issue a refund because a participant is not sufficiently physically fit to participate in any part of a course.
- 12. We may require additional information depending on the medical information supplied to us by you when you apply for a place on a course. You will be contacted by a member of our team in this instance.
- 13. In the event that the participant needs medical attention during any course you agree to us arranging for any appropriate and necessary treatment and the contact of emergency services if required.

#### **Liability**

- 14. You are responsible for arranging personal possessions insurance for the duration of the selected course. we advise that participants do not attend with valuable items, as a precautionary measure.
- 15. Neither you nor we shall be liable to the other for any loss or damage the other suffers as a result of a breach of these terms and conditions, unless that loss or damage was reasonably foreseeable at the time of agreement of these terms and conditions.

- 16. Nothing in this agreement excludes or limits in any way our liability for: (a) death or personal injury caused by our negligence; or (b) fraud or fraudulent misrepresentation; or (c) any other matter for which it would be illegal or unlawful for us to exclude or limit or attempt to exclude or limit our liability.
- 17. The cost of any damage caused by you or any participant you have booked on a course to any property or facilities will be passed on to you and you will be liable to pay it.
- 18. Public Liability is held by RBFD. Please ask for details of this and they can be provided.

#### **Staff & Camp Protections**

- 19. During our courses we may run competitions such as tournaments, penalty shootouts etc. The decision making and prize awarding for such competitions is afforded to our qualified coaches and these decisions are final.
- 20. Any prizes offered are non-transferable and there is no cash alternative. We reserve the right to substitute prizes of equal or greater value at any time.
- 21. Participants on courses must comply with the Course Regulations, all rules and regulations that apply at any location where courses are provided, and all instructions of course leaders and other staff at any location where courses are provided.
- 22. We treat as a priority the safety and wellbeing of all participants attending our courses. We therefore reserve the right to remove from our courses, without refund, any participant who contravenes with these, is found bullying, behaving in a way that may be a danger to others, or who is generally disruptive.
- 23. If a participant is removed from a course it is your responsibility to organise their travel arrangements home. A member of our team will be in-touch with you to notify you and arrange for their collection.
- 24. As football is a contact sport, injury may result from partaking in our courses. You understand that said injury is a reasonable risk, and that as long as there has been no neglect of duty on the part of our staff, that RBFD hold no liability for this.

#### Sponsorship/Advertising

- 25. As part of the funding that allows us to provide new and improved equipment for your child, companies (selected by us) may pay for advertising/sponsorship. With this we (never a third party) will send out carefully selected promotions/offers from companies who support and fund our work with Youth in the Community.
- 26. You agree to grant to us the right indefinitely, without the need for further approval or compensation, to use the participant's photograph, video or film portrayal, image, likeness, interview, voice or sound of any participant in any media whatsoever for the purpose of advertising, promotional or other commercial purposes, unless you have stipulated otherwise when asked at registration.
- 27. Photographs for or on behalf of us are taken by personnel who hold a DBS/CRB only, on professional RBFD owned cameras and phones.
- 28. Participants may be supplied with RBFD bibs which they will be required to wear at specified activities during the course.

#### The Technical Bits

- 29. The contract between you and us is binding and on the respective successors and assignees of you and us. You may not transfer, assign, charge or otherwise dispose of this contract, or any of your rights or obligations arising under it, without our prior written consent. We may transfer, assign, charge, sub-contract or otherwise dispose of this contract, or any of our rights or obligations arising under it, at any time during its term, provided that the person to whom we transfer, assign, charge, sub-contract or otherwise dispose of this contract or any of our rights or obligations arising under it agrees to comply with all of its terms for your benefit.
- 30. If we fail to insist upon strict performance of any of your obligations, or if we fail to exercise any of the rights or remedies to which we are entitled, this will not be a waiver of such rights or remedies and will not relieve you from compliance with such obligations. A waiver by us of any breach by you will not constitute a waiver of any subsequent breach. No waiver by us of any of these terms and conditions will be effective unless it is expressly stated to be a waiver and is communicated to you in writing.

- 31. If any court or competent authority decides that any of these provisions are invalid, unlawful or unenforceable to any extent, the term will, to that extent, be severed from the remaining terms, which will continue to be valid to the fullest extent permitted by law.
- 32. These terms and conditions and your booking shall be governed by and interpreted in accordance with English law and shall be subject to the non-exclusive jurisdiction of the English courts.

#### **General Data Protection Regulation**

- 33. We're committed to protecting your privacy so you can feel confident about the information you provide. As such:
- The data you provide is used; fairly and lawfully; specifically stated purposes; in a way that is adequate relevant and not excessive; for no longer than is absolutely necessary; accurately according to people's data protection rights; safe and securely.
- -Your data is NOT transferred to third parties nor is it transferred outside the European Economic Area without adequate protection.
- 34. From time to time we may send out carefully selected advertisements for RBFD and RBFC services. Please note that these will be sent by us and not by any third party. If you do not wish to receive these, respond to notify us at any point.
